

Appendix Table A2. Determinants of Southern Black Adults' Media Consumption

Note: Based on the Negro Political Participation Study (Matthews and Prothro, 2006). This table presents the estimates in Figure 3 of the paper. Each column reports estimates from a separate OLS regression. The outcome is

whether the respondent consumed each type of media (shown at the top of the column) regularly during 1961-1962. Each regression includes the set of individual socioeconomic characteristics shown in the table as well as county fixed effects. Standard errors, shown in parentheses, are clustered at the county level. P-values from the wild cluster bootstrap procedure are in curly brackets and are based on 1,000 replications. *** p<0.01, ** p<0.05, * p<0.1
